There are four honorees for this year's event: Max Metcalf; Legacy Charter School (William W. Brown and Fred Crawford); The Hon. Judge Jasmine Twitty; and Absolute Total Care. Legacy Charter School (Crawford and Brown) will receive the Xanthene Norris Educational Award.
- I participated in the SC Public Charter School District's regional Operators' Meetings on January 23rd in Spartanburg, SC. The meeting was very beneficial for planning Legacy's transition to the new charter sponsor along with receiving legislative updates on SCPCD school expansion.
